ADMISSIONS FOR THE ACADEMIC YEAR 2019-20

1. The Provisional Merit List of Candidates for admission to 1st Year of 5 Year Integrated BBA LLB Course at Army Law College, Pune was published on 31 May 2019. The salient points of the admission process are enumerated as under for the information of Candidates.
2. The receipt of application has since closed on 20 May 2019. Only wards of Army Personnel (serving & retired) verified as bona fide Candidate after online registration on college website www.alcpune.com and submission of MAH LL.B (5 YEARS) CET-2019 marks will only be eligible to participate in the further admission process.
3. Candidature will be subject to furnishing correct information and documents as notified on the College website.
4. Eligibility Criteria. Attention of all Candidates is drawn to eligibility criteria and rules for admission as enumerated in Prospectus 2019-20 of Army Law College, Pune (Refer Para 15).
5. Online Verification of Eligibility Criteria. In order to enable the Admission Committee to ascertain the eligibility, all candidates will ensure submission of the following mandatory documents, as applicable, by forwarding them as email attachments for verification as per the remarks on the Provisional Merit List to confirm their eligibility for admission at Army Law College, Pune:
 - (a) Dependent Certificate as per the applicable format, as under:
 - **Certificate -1** (Children of Army Personnel Serving / Retired/Released / Discharged after 10 years Service/ Killed in Action/ Died while in Service / Disabled in Action / Medically Boarded out with Pension.)
 - **Certificate - 2** (Adopted Children of Army Personnel at least 5 Years Prior to Seeking Admission.)
 - **Certificate -3** (Children of Army Medical Corps/ AD Corps Officers Serving in AF/ Navy Establishments / TA Personnel having 10 Years of service in Army.)
 - (b) 12 Std Result Card/ Copy of marksheet.
 - (c) SBI Collect transaction Receipt in r/o remittance of Rs 1000/- as application Fee to Army Law College, Pune.
6. Allotment of Seats. Allotments of seats for admission to 1st Year BBA LLB will be on the basis of marks obtained in MAH-LL. B(5YEARS) CET-2019(Integrated Course) by eligible Candidates. A reserve list as of candidates will also be notified along with candidates allotted seat, initially. The reserve list candidate will be required to register by making a payment of Rs. 10,000/- as Registration Fee and give willingness to be considered as reserve within prescribed time in order to be eligible for consideration as reserve for allotment of vacant seats. The registration as reserve however does not guarantee allotment of a seat unless a vacant seat is allotted, in the order of merit, to such reserve candidate. A confirmed allottee of seat will be required to pay full College fee (1st Year) within the time notified, failing which the offer of seat to such candidate shall automatically stand cancelled. The vacancies remaining after the non-acceptance of the offer by a Candidate will pass on to next eligible reserve Candidate in the order of merit, after the notified offer period.
7. Counseling. The offer of seats will be to verified Candidates only. The Candidates lacking submission of essential documents as per Para 4 should submit the concerned documents by email to armylawcollegepune@gmail.com in order to remain in the further admission process. The date of submission of mandatory documents is extended to **14 Jun 2019**. Final merit list shall consist of Candidates whose eligibility criteria as ward of Army Personnel is duly verified and are confirmed to have attended MAH LL. B (5Years) CET 2019. Candidates must also submit due authority of award / battle casualty in r/o the parent in order to avail grant of weightage in marks as per the Eligibility Criteria.
8. Offer of Seats. There are 60 seats to be allotted. Allotment will be strictly in order of merit as per the final merit list published by the Institution.
9. Payment of Fee. All Candidates confirmed to be allotted a seat will pay the College fee applicable for 1st Year BBA LLB within 07 days of such offer. Those Candidates who fail to accept the offer of the allotted seat within the offer period will forego their chance to a seat once the offer period expires. Refund of fee / Registration Charge will be in accordance with AWES Rules enumerated in Prospectus 2019-20.
10. Verification of Documents. All original documents will be physically verified at the time of joining the College and provisional admission granted shall be confirmed after acceptance of eligibility of a candidate by Savitribai Phule Pune University. Any false document/ testimonials used by a Candidate for the purpose of obtaining admission to the College will render the candidature null and void even if detected at a later stage.
