INSTRUCTIONS TO CANDIDATES

1. The online procedure for confirmation of seat for admission to 1st Year B.B.A.LL.B is outlined as under.
2. Candidates - Merit Serial 01 to 60, i.e. Admission List No 1: With declaration of Admission List No 1, the offer of confirmed seat for admission to 1st Yr B.B.A.LL.B is open to Admission List candidates i.e. upto Ser No 60 of Final Merit List. The concerned candidate is required to confirm his/her seat by making payment of Annual Fee including One Time Charges as per the ALC Prospectus 2020 by 10th Dec 2020, before 8:00 P.M. After completing the fee payment candidate must intimate the details of the transaction by email to admission.alcpune@gmail.com giving Candidate Name & MHCET Regn Number, Bank Name, Transaction No./ UID No./ Ledger ID No. (incase Bank Transfer) with date. The amount payable by Admission List No1 Candidates is ₹ 1,63,760/- (Rupees One Lakh Sixty Three Thousand, Seven Hundred & Sixty only) which excludes Hostel Fee. The Hostel Fee as per the ALC Prospectus 2020 will be payable as and when the permission of Govt./ University is accorded.
3. Candidates - Merit Serial 61 to 96 : Vacant seats from Admission List No 1 will be allotted to Candidates who register as reserve for allotment by making a token payment of ₹ 10,000/- (Rupees Ten Thousand only).The Candidates at Merit List ser 61 to 96 may register as reserve, from 04th Dec 2020 to 10th Dec 2020, till 8:00 P.M., to be considered as reserved for allotment of vacant seats, in their order of merit. Such candidates, who opt as reserve for allotment of vacant seat, shall after completing the payment transaction of ₹ 10,000/- (Rupees Ten Thousand only) shall intimate the details of the payment made by email to admission.alcpune@gmail.com giving Candidate Name & MHCET Regn Number, Bank Name, Transaction No./ UID No./ Ledger ID No. (incase Bank Transfer) with date. The registration amount collected will be merged with the fee payable by the candidate if the confirmed seat is allotted to a reserve list candidate. Otherwise, the registration amount will be refunded back after deducting the processing charge. Therefore, if an offer of a confirmed seat is given to a reserve list candidate, and if he/she accept the confirmed seat then full annual fee less the registration amount, i.e. ₹ 1,53,760/- (Rupees One Lakh Fifty Three Thousand, Seven Hundred & Sixty only) which excludes Hostel Fee, shall be paid.The Hostel Fee as per the ALC Prospectus 2020 will be payable as and when the permission of Govt./ University is accorded.
4. Admission List No 2 will be announced on 11 Dec 2020 for filling of seats, if any, not subscribed by the Admission List No 1.
5. Candidates are advised to use their registered email ID to communicate with Army Law College, Pune email ID: admission.alcpune@gmail.com .
6. Method of Fee Payment :
 - (i). Using SBI Collect App Registered for ALC Pune. Use the link of 'Pay Fees' under Students menu on ALC Pune website. Use MH CET Regn No. for Roll Number. No characters, eg. / , - : . # to be used while filing an address in SBI Collect app. Link - <http://alcpune.com/students/pay-fees/>.
 - (ii). NEFT/ RTGS/ IMPS/ Bank Transfer. The payment can be made to ALC Pune Fee Collect Account at SBI Dehu Road (Pune), Current Account Number : 38218088478, IFSC Code : SBIN000569. Candidate's First Name & CET Regn No. should be included in remarks, eg. 'Ashok-4401212'
